


CAREER PROSPECTS @ LAW



LAW COURSES OVERVIEW

LLB (3 YEARS)

LLB is 3-years law degree course during which it provides a comprehensive understanding of various aspects of law. LLB syllabus comprises courses such as Contract Law, Criminal Law, Civil Law, Property Law, Corporate Law, and Constitutional Law. The course is offered by the colleges approved from the Bar Council of India.



BALLB (5 YEARS)

BALLB is a 5-years law degree course which has a combination of Bachelor of Arts and Bachelor of Laws, these are two highly different degree courses. It prepares students for a career in law, Government and non-Government services, private practice, and research or a legal professional. The course is offered by the colleges approved from the Bar Council of India.



LLM (2 YEARS)

LLM is a 2-years postgraduate degree in law. LLM helps to gain an in-depth knowledge of a particular field of law through intensive research in that field of law. Master of Laws offers various specializations such as constitutional & administrative law, business law, torts & criminal law, commercial & criminal law, environmental law, taxation law, intellectual property law & many more.



PG DIPLOMA IN CYBER CRIME & LAW (1 YEAR)

A Post Graduate Diploma in Cyber Crime and Law typically provides a comprehensive understanding of cybercrime investigation techniques, digital forensics, cybersecurity laws, and ethical hacking. Students learn about cyber laws, data protection, cybercrime prevention, and mitigation strategies. LLM (2 YEARS)


